**BY MY SIGNATURE, I AGREE TO CHARGES TO MY CREDIT CARD FOR PAYMENT and TO ALL POLICIES REGARDING THE GOLF MEMBERSHIP AND PAYMENT PLAN.**

The annual dues for the Mountain View Country Club payment plan shall be payable in three (3) equal monthly installments. The first installment shall be due on or before March 10, 2025, and the subsequent installments shall be due on or before the 10th day of the following two months. The installments may be paid in cash, personal check, bank check, by debit card, or by credit card. In the event the Member elects payment by debit card or credit card, the Member hereby authorizes the Club to automatically draft the Member's account on the tenth (10th) day of March, April, and May 2025. The Member further authorizes the Club to conduct an initial draft of one dollar (\$1.00) on the day the membership application is received by the Club, to ensure the account's and/or debit card or credit card's validity.

The Member understands that in the event of failure to pay any of the monthly installments (which shall include the Member's debit card or credit card being declined) by the aforementioned due dates, the Club shall have the right to terminate the Member's membership and all rights and privileges of the Club with no refund of any amount previously paid by the Member. The Club also retains the right to pursue the Member for any unpaid installments and/or dues, the remaining balance of which shall become automatically due, and may pursue any additional remedy available in law or equity. The Member hereby agrees that in the event of nonpayment of installments when due, no notice shall be required for the Club to exercise these rights.

## **POOL MEMBERSHIP RELEASE & ASSUMPTION OF RISK**

For and in partial consideration of receiving a pool membership for Brymac, Inc. d.b.a. Mountain View Country Club, or Per Ardua, LLC d.b.a. Wyndham Garden State College, Boalsburg, Pennsylvania (hereafter, collectively referred to as "the Releasee"), which membership permits the undersigned and his/her minor child or children whom are specifically listed below (hereinafter, collectively referred to as "the Releasers"), to enter upon and use the swimming pool and its attendant facilities, located at the Wyndham Garden State College, 310 Elks Club Road, Boalsburg, Pennsylvania, during a previously agreed upon time period, the receipt of such membership being hereby acknowledge, the undersigned hereby releases the Releasee, its subsidiaries, agent, officers, servants, employees, and any and all other representatives of the Releasee from any and all liability, claims, demands, actions, and causes of action, whatsoever, arising out of or related to any loss, damage or injury, known or unknown, that may be sustained by the Releasers or sustained by any property of any or all of the Releasers, even though that liability may arise of our Releasee's negligence or carelessness or out of the negligence or carelessness of any persons or entity mentioned above.

The undersigned further agrees to hold harmless and indemnify the Releasee, its subsidiaries, agents, officers, servants, employees, and any and all other representatives of the Releasee from any and all liability for death or personal injury or property damage resulting in any way from any of the Releasers' entering upon or using the aforementioned swimming pool and facilities.

The undersigned knows, fully understands and fully appreciates that entry upon and use of said pool and facilities carry significant risk of personal injury and that the said pool and facilities contain significant inherent hazards. Said risks include, but are not limited to drowning, slipping and/or falling on wet surfaces, and injury due to diving. Said hazards include but are not limited to, surfaces that are sometimes wet and shallow areas in the pool. With this full knowledge, understanding and appreciation of the risks and hazards associated with the entry upon and the use of said pool and facilities, the undersigned knowingly and voluntarily assumes all risks of loss, damage or injury that may be sustained by any of the Releasers or by any property owned by any of the Releasers while in, on or upon said pool or facilities or because of having been in, on or upon said pool or facilities, even if said risk arises or is increased by or attributable in any way to the negligence of the Releasee or any of its subsidiaries, agents, officers, servants, employees, or other representatives. The undersigned expressly assumes all such risks on behalf of himself or herself and on behalf of each of his/her minor children who are specifically listed below.

This release shall be binding upon the distributees, heirs, assigns, next of kin, executors and administrators of any and all of the Releasers.
